Calzolari S.r.l, P.IVA: 00128840204, owner of the website https://www.calzolariarredourbano.eu/ (hereinafter "website"), as the Controller of users personal data (hereinafter "Users") provides this privacy policy according to (art. 13) UE Regulation 2016/679 (hereinafter "Regulation").

This Website and any services offered through it are reserved for adults (at least 18 years old). Therefore, the controller does not knowingly collect personal data related to individuals under the age of 18. Upon user request, the Controller will promptly delete any minor's personal data unintenitionally collected. For any questions regarding this privacy policy, Users can contact the Controller at any time using the following methods:

1. Categories of Data Processed:

The data processed includes:

- a) a) All personal data whose transmission is implicit in the use of Internet communication protocols and which is collected by the IT systems and software procedures responsible for the operation of the Website during their normal operation: IP addresses or domain names of the computers used by Users, URI (Uniform Resource Identifier) addresses of requested resources, the time of the request, the method used to submit the request to the server, the size of the file received in response, numerical status codes (success, error, etc.), and other parameters related to the User's operating system;
- b) In addiction, the Controller may process further personal datas, if voluntarily and personally submitted, just in case of separeted e-mail sent by the user in the contact section.

2. Purpose of the processing

Users personal data will be lawfully processed by the Controller (Article 6 of the Regulation) for the following purposes:

- a) Surfing the webSite. The User's data (no. 1, letter a) collected by the Data Controller for this purpose includes all data used just to obtain anonymous statistical information on the use of the Site and to enable its proper functioning. Without prejudice to the provisions elsewhere in this privacy policy, under no circumstances will the Data Controller make Users' personal data accessible to other Users and/or third parties. The user is informed via the cookies used and of the option to select third-party cookies, profiling cookies, and other cookies indicated therein. The user always has the option to change their consent via a banner on the site. No other processing will be carried out by the Data Controller in relation to Users' personal data. Without prejudice to the provisions elsewhere in this privacy policy, under no circumstances will the Data Controller make Users' personal data accessible to other Users and/or third parties;
- **b)** Responding to User requests: Further datas voluntarily submitted (n.1, lett. b) are collected and processed by the Controller just to respond to User request;
- **c)** Legitimate interests: the datas obtained may be used in order to protect the legitimate interests of the Controller (litoigation).

Users can request clarification on the legal basis for processing at any time.

Providing personal data for the purposes listed above (lett. **a**, **b**,**c**) is necessary— since, otherwise, their omission cause the inability for the Controller to fulfill the User's request.

3. Data processing Methods and Period of Retention

Data are processed using manual and electronic tools in accordance with the purposes stated above (n. 2), ensuring the security and confidentiality of the data.

User data will be stored only for the time strictly necessary to fulfill the purposes mentioned or as needed to protect the rights of both the Users and the Controller.

4. Data Disclosure and Communication Scope

Subjects responsible for managing the Website and User requests may access the personal data. These individuals are properly instructed under Article 29 of the Regulation and will process data only for the purposes outlined.

Additionally, third parties may process data on behalf of the Controller as "External Data Processors," such as IT service providers, cloud computing vendors, professionals, and consultants.

Users can obtain a list of external data processors by contacting the Controller as indicated in Section 6.

5. Data Transfers

The data are not transferred to extra EU countries. However, the Controller may use cloud services; in these cases, providers will be selected based on their compliance with Article 46 of the Regulation, ensuring appropriate guarantees.

6. Rights

Users can exercise their rights under the Applicable Law by contacting the Controller choosing two different ways:

- By registered mail: Via Cadellora 4/6, Gonzaga (MN);
- By Certified Eletronic Mail: cert.postecert.it, or by e-mail: info@calzolarisrl.it

User's rights are explanted in artt. 12-22 Eu Regulation 2016/679, in addiction to the right to revoke consent at any time without affecting the lawfulness of prior processing (art. 7). Finally, Users have the right to file a complaint with the Supervisory Authority under Article 13.2(d) and Article 77 of the Regulation.
